This Direct Debit Request ('DDR') Service Agreement is issued by Freedom Leisure Finance Pty Ltd (FLF). You should direct all enquiries about your direct debit to Freedom Leisure Finance.

1. Our commitment to you

This document outlines our service commitment to you, in respect of the DDR arrangements between FLF and you. It sets out your rights, our commitment to you and your responsibilities to us together with where you should go for assistance.

Initial terms of the arrangement

In terms of the DDR arrangements made between us and signed by you, we undertake to periodically debit your nominated account for the agreed amount for your FLF loan.

- a) The first drawing under this DDR will occur one (1) month following the loan draw down date.
